

General Terms and Conditions for Visitors

These General Terms and Conditions apply to visitors to LEGAL LIVE (the “Event”) organized by LEGAL (R)EVOLUTION GmbH (the “Organizer”).

1. Visit to the trade fair and the specialist congress

1.1 The Organizer can cancel a registration for the Event if the person registered does not belong to the visitor groups according to section 1.2. You can also cancel a registration if there are other objective reasons, for example if the software tools of the Event are not used for the intended purpose.

1.2 LEGAL LIVE is a virtual trade fair for trade visitors. Only members of the following organizations are entitled to visit LEGAL LIVE free of charge:

Law firms, tax consultancies and auditing firms, legal departments, compliance departments. Tax departments, digitization departments, IT departments, HR departments, M&A departments, regulatory departments, alternative legal service providers, notaries' offices, insolvency administrations, judicial authorities, justice ministries and chambers of justice, press and reporting, academic institutions and universities. In order for the visitor to have access to the Event, a registration via the [website](http://www.legallive.net) legallive.net and a login on the Event platform talque.com. When logging in to the Event platform, the visitor sets up a personal profile by answering or specifying questions about the person (first and last name, company, position, city, profile picture, etc.) and main interests. The profile is available for all LEGAL LIVE participants for the duration of the Event from 23.03. - 25.03.2021 and is used for interactive contact.

1.3 If you do not belong to any of the aforementioned visitor groups, you can purchase a ticket for EUR 249 plus sales tax. Please contact info@legal-revolution.com for this. On request, visitors show us that they belong to one of the visitor groups. If they do not comply or if the classification turns out to be incorrect, we will charge an amount of EUR 249 plus VAT.

1.4 The Organizer reserves the right to deny a visitor entry or stay on the Event platform if he/she is doing advertising at LEGAL LIVE without being registered as an exhibitor, demonstrably demonstrating unethical behavior or using LEGAL LIVE's communication options for uses purposes outside of the technical topics of LEGAL LIVE and does not comply with the regulations set out in these general terms and conditions. The Organizer will not reimburse any expenses incurred as a result.

2. Cancellation conditions and changes

Visitor registrations and the profiles on the Event platform are personalized, cannot be rewritten and are not transferable. A visit to LEGAL LIVE can be canceled free of charge by email at info@legal-revolution.com.

3. Cancellation due to COVID-19, force majeure

3.1 The Organizer reserves the right to cancel the Event in whole or in part until March 22nd, 2021 for reasons related to the COVID-19 virus, for example because it reassesses the risk situation due to COVID-19. The cancellation is considered a withdrawal from the contract(s) between you and the visitor. 3.2 The Event can be canceled for the following reasons, among others: Force majeure such as war, terrorist attacks, natural disasters, uprisings, strikes, by virtue of the law or for any other reason for which the Organizer is not responsible.

4. Privacy and privacy policy

5. Liability

5.1 The Organizer is not responsible and is not liable for damage caused by anyone other than the Organizer himself, their legal representatives or vicarious agents.

5.2 The sponsors or exhibitors of the Event are not considered to be vicarious agents of the Organizer.

5.3 If a visitor harms a third party, he is obliged to indemnify the Organizer from all claims made against it based on this damage.

6. Applicable Law and Jurisdiction

6.1 These contractual conditions are subject to German law.

6.2 Frankfurt am Main is agreed as the place of jurisdiction.
